ORGANOGRAM



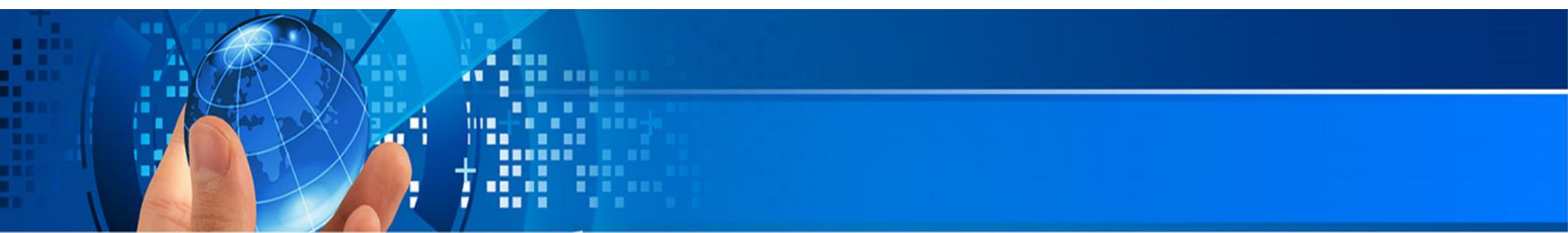
